Medical Eligibility Requirements and Procedures for Intercollegiate Athletics Participation

PLEASE READ ALL REQUIREMENTS THOROUGHLY

The medical eligibility requirements for all students participating in intercollegiate athletics at the University of Southern Maine (USM), the Pre-Participation Physical Evaluation (PPPE) procedures and the PPPE Schedule for 2025 are described below. Prospective student-athletes should read all information carefully prior to arriving for a **Required** PPPE appointment at University Health and Counseling Services (UHCS).

MEDICAL ELIGIBILITY REQUIREMENTS:

Each of the following requirements <u>MUST</u> be met <u>prior</u> to being administered the PPPE at UHCS and <u>prior</u> to participating (includes try-outs and conditioning practices) in intercollegiate athletics at USM:

- 1. Pre-Participation Physical Evaluation (PPPE): An initial comprehensive PPPE is required to be administered at the UHCS for all "new (includes transfers)" student-athletes prior to participation in intercollegiate athletics at USM. Your primary health insurance will be billed for the physical examination at the time of the PPPE. Please note that most insurance plans will only pay for one annual physical examination per year. A health history and PPPE update, including blood pressure check, is also required to be administered at the UHCS for all returning student-athletes prior to participation in intercollegiate athletics at USM, on an annual basis. The returning athlete PPPE is billed to your insurance as a blood pressure check/medical history review. In the event a health concern, that requires examination beyond the scope of a physical, is brought up during the exam, additional charges may apply. All PPPEs for initial and returning student athletes must be conducted at the UHCS in 156 Upton Hall and on the Gorham campus. The schedule for the PPPE can be found here: Pre-Participation Physical Evaluation University Health Services. USM does not require a physical simply to enroll as a student. PPPE Scheduling conflicts must be resolved in advance by contacting USM Athletic Healthcare via email at usmathletichealthcare@maine.edu
- 2. Student Portal Health Record (required to be completed/updated annually): Prior to arriving for the scheduled PPE appointment each student-athlete must complete the appropriate Health History (New or Returning Student) forms that can be found under "Student Athlete Pre-Participation Forms" in the Health Record. The Health History or Health History update, along with all other required medical eligibility forms (listed below) must be completed by July 31, 2025, for all sport participants. USM Athletic Healthcare Services Staff (ATs), the UHCS and USM Team Physicians will be the only individuals with access to the Health History Summary
 - a. Athletics Health History/Health History Update Participation (required form on Health Record): First year/transfer student athletes should complete the Athletics Health History Form. Returning athletes ONLY need to complete the Health History Update Form.
 - b. Primary Health Insurance Coverage Requirement & Acknowledgement (electronic signature required in Health Record): Student-athletes must carry adequate health and accident insurance coverage to defray the cost of any injury or illness that may be incurred while participating in intercollegiate athletics at USM. Written verification in the form of a current insurance enrollment card or certificate of enrollment from the student's own health insurance company must be documented in the Health Record of the Patient Portal prior to PPE. An image of both sides of the health insurance enrollment card must be uploaded to the Health Record under the "Insurance" section.
 - i. The PPE will not be administered without this written verification. A COPY OF THE PREVIOUS YEAR'S ENROLLMENT CARD IS NOT VALID!
 - ii. Student-athletes <u>NOT</u> presently covered by individual or parental health insurance must secure adequate health insurance prior to participation in intercollegiate athletics at USM

- iii. Domestic students may enroll in the voluntary student health insurance plan. Information can be found via student financial services at <u>Student Health Insurance Student Financial Services</u> (maine.edu)
- iv. International students should check with the Office of International Programs 207-780-4959 to consider enrolling in the international health insurance plan or the USM voluntary Student Health Insurance Plan.
- v. Medicaid (e.g. MaineCare) generally do not cover students for out-of-state health care needs other than medical emergencies (if you have a similar plan from a state other than Maine, you may need different coverage for athletics participation).
- vi. The Athletic Department carries a rider policy, administered through Gallagher Health, that provides limited insurance coverage for student-athletes from \$1,000 to \$90,000. You must meet the \$1,000 deductible threshold with other insurance before this rider policy takes effect.
- vii. The NCAA provides all member institutions with catastrophic insurance coverage for intercollegiate athletics that begins at \$90,000 (deductible amount)
- viii. It is the responsibility of the student-athlete to notify the USM Athletic Healthcare Services Staff regarding insurance coverage changes or if coverage has been discontinued for any reason, while participating in athletics
 - 1. Student-athletes with lapsed coverage become immediately ineligible to participate in intercollegiate athletics at USM
- ix. If none of the above insurance options will work for you, please contact Greater Portland Health at 207-874-2141 to schedule an appointment with a financial assistance counselor and they may be able to assist you with enrolling in an insurance policy through the Affordable Care Act.
- c. <u>Emergency Information (required form on Health Record)</u>: Each student athlete is required to complete and electronically sign this form prior to arriving at UHCS for their PPPE appointment. Please include <u>at least ONE</u> emergency contact. If you do not have someone to list, please contact us at <u>usmathletichealthcare@maine.edu</u>.
- d. <u>Assumption of Risk for Athletic Participation (required form on Health Record)</u>: Each studentathlete is required to complete and electronically sign this form prior to arriving at UHCS for their PPPE appointment
- e. <u>Injury/Illness Sport Related Concussion Reporting Acknowledgment (required form on Health Record)</u>: This form must be completed and electronically signed by all student-athletes on an annual basis prior to participation in athletics. *Student-athletes are required to review the educational NCAA "Fact Sheet" and then electronically sign the form in their Health Record prior to arriving at UHCS for their PPE appointment.*
- f. Release of Health Information from UHCS to AHS and from AHS to UHCS (required form on Health Record): This form allows health information to be shared between Athletic Healthcare Services (AHS) and University Health and Counseling Services (UHCS) throughout the year. Any information shared relates to health information that may affect athletic participation. Each student-athlete is required to complete and electronically sign this form prior to arriving at UHCS for their PPE appointment.
- g. Sickle Cell Trait Testing (required form on Health Record): The NCAA requires that all first year and new student-athletes participating in athletics provide results of Sickle Cell Trait Testing (may have been completed at birth) and must receive education regarding this condition. Each student-athlete has the following options to comply: Submit test results or consent to have testing done at UHCS. The Sickle Cell Trait Testing Form is available on the Health Record website. Returning student-athletes who have completed the testing at USM, submitted test results or previously completed a waiver, will not be required to be retested. Student-athletes are required to review the educational NCAA "Fact Sheet" and watch a 6:22 minute educational "video" on Sickle Cell Trait. Both the Fact sheet and the video are imbedded as web links on the Sickle Cell form in the health record. The form must then be electronically signed prior to arriving at UHCS for their PPE appointment.

- i. All newborns in the United States are tested for Sickle Cell Trait. Student-athletes may be able to search out those birth records and submit them to the University Health Services or have testing done by their primary care provider.
 - 1. We strongly suggest having the testing done and uploading your test results to the Health Record prior to arriving on campus to avoid any delays in eligibility.
 - 2. If you are unable to have the testing performed prior to arriving on campus, please contact the Athletic Healthcare Staff at usmathletichealthcare@maine.edu for options on testing at UHCS. The fee will be billed to the student-athletes insurance.
- 3. <u>Student Portal Health Record Optional Forms</u>): The forms listed below should be completed and uploaded in Health Record or sent to the Athletic Healthcare Staff **IF** they apply to you.
 - a. Minor Consent (form available on Health Record): Student-athletes under age 18 at the time of the PPE at Health Services are required to have written parent/guardian permission prior to completing the PPPE. The Minor Consent form can be found on the Health Record under Athlete Pre-Participation forms after logging in.
 - b. Significant Medical Condition(s): Student-Athletes with a significant medical history of injury or illness may be required to provide medical <u>records specific to the condition</u> and possibly written clearance from an appropriate health care provider prior to athletic participation. Students anticipating this situation should contact Kelleigh O'Neill, Director of Athletic Healthcare, via email at <u>usmathletichealthcare@maine.edu</u> well in advance of the scheduled PPE date. A Medical Records Release Request form <u>"Health Information Release from Third Party to AHS"</u> should be downloaded <u>from Health Record under Pre-Participation Forms</u> to submit to your healthcare provider for request of records related to any medical condition that may affect clearance to participate. Download and submit this form to your appropriate healthcare provider well in advance of the scheduled PPPE.
 - c. <u>Medications or Nutritional Supplements Disclosure*</u>: The NCAA requires that student-athletes disclose any and all medications (prescription or over the counter) or nutritional supplements that they may be using. You will be asked about medications or supplements in the on-line health history questionnaire.
 - i. If a student-athlete has been diagnosed with ADHD (Attention Deficit Hyperactivity Disorder) and is taking legitimately prescribed medications, which may be on the NCAA banned substance list, such as Adderral, Vyvance, Concerta, Ritalin, etc, further documentation must be acquired by the student-athlete from their treating physician. This must be done prior to competing in intercollegiate athletic activities at USM. If a student-athlete is drug tested and tests positive for an NCAA banned substance he/she must file for medical exception. A copy of the NCAA Medical Exception Documentation Reporting Form is available in the Health Record under "Form" then "downloadable forms" You must download this form and submit to your appropriate healthcare provider requesting medical documentation.
 - ii. Other medications that are commonly used and require the "Medical Exception Documentation Reporting Form" to be completed are: Inhalers & Spironolactone.
 - iii. Any student-athlete that is prescribed Anabolic Agents or Peptide Hormones must complete a NCAA Medical Exception Documentation Reporting Form (form is available on Health Record). This form is for pre-approval and must be completed prior to participation in athletic related activity. You must download this form from Health Record and submit it to your appropriate healthcare provider requesting medical documentation, prior to participating in intercollegiate athletics.

- iv. If you are taking a medication or supplement and are unsure if you need to complete the NCAA medical Exception, please contact the Athletic Healthcare Staff at usmathletichealthcare@maine.edu
- v. It is the student-athletes' responsibility to produce the necessary documentation and submit it to USM Athletic Healthcare Services as a part of the PPPE process.
- 4. **SWAY Baseline Concussion Testing (required for first year student-athletes at USM)**: Each student-athlete is required to complete SWAY baseline concussion testing. This testing will be incorporated into the PPPE process and will be conducted in the Athletic Training Lab in the Costello Complex. **First-Year and Transfer Student-Athletes are not cleared for participation until this baseline concussion testing has been completed.**
- 5. Immunization Shot Records: Must be up-to-date and on-file at UHCS. Student athletes should go to Immunization Compliance University Health Services (maine.edu) for the current immunization requirements and to download a copy of the form Student-athletes are required by the NCAA to submit immunization shot records for participation in intercollegiate sports. There is no opting out for student-athletes.
