

Completing Submission and Certification Routing



Students and Faculty Advisors (FA) and/or Co-PIs

It is recommended that the student notify their Faculty Advisor when a draft is complete BEFORE they Complete Submission and Certify the submission. Once certified, the FA cannot review and make any edits. ORIO staff can send it back; however, that is an extra step and takes time.

Faculty Advisor reviews first before either Complete and Certify the submission at the end.
