# **Course Objectives**

The primary objective of this course is to study the legal environment in which businesses operate as well as various legal issues presented by the operation of a business. In achieving these objectives, students completing this course should:

- 1. Develop a conceptual and substantive understanding of business law.
- 2. Understand how the application of business law is a critical consideration in business decision-making.
- 3. Gain an awareness of the economic, social, political, and ethical reasoning behind various business law provisions.
- 4. Recognize the legal implications presented in various unstructured fact-based scenarios and apply the applicable substantive legal principles in order to develop defensible conclusions and recommendations.
- 5. Develop an awareness of the various ethical issues that may arise when operating a business.
- 6. Strengthen written and oral communication skills.

# **Homework**

All assigned reading and homework should be completed prior to class. Homework assignments will be posted to Brightspace and/or Cengage periodically. **These Homework assignments will constitute a portion of your final course grade**. In order to get credit for a particular assignment, it must be submitted by the due date. **I will not accept late homework.** 

You should come to class prepared to participate in our discussions—your level of engagement in this class constitutes a portion of your final course grade. I do not believe you can successfully complete this course without completing the assigned material so it is in your best interests to complete the homework assignments not only to get credit towards your final grade but also to give you the practice necessary to understand the material.

## **Projects/Assignments**

During the semester, you will complete the following Projects/Assignments. In order to get credit for a particular assignment, it must be submitted by the due date (see attached Tentative Course Schedule). **Please plan ahead as I will not accept late work.** Specific instructions for each assignment will be distributed to you later in the semester.

- <u>Legal Analysis Hypothetical</u>: You will complete a written assignment that will require you to apply business law concepts in the context of a brief hypothetical scenario. Your analysis must be presented using the "IRAC" format (Issue, Rule, Analysis, Conclusion--to be discussed in class) for legal analysis. The purpose of this activity is to develop your analytical and critical reasoning skills while also giving you an opportunity to work on your written communication skills. Your grade on this assignment will be based on both content and writing skill.
- <u>Business Entity Assignment</u>: You will complete an assignment designed to increase your familiarity with the law surrounding the formation and operation of business entities.

#### Exams

The course will consist of 2 interim examinations (the last one being administered during the Finals period). **The final exam will <u>not</u> be cumulative**. Exams must be taken during the period when scheduled. Absences from a scheduled exam without prior approval may result in a grade of zero. Approval to be absent from an exam will only be granted in cases of personal emergency or illness. Written verification may be required. Those exams cancelled due to weather or other circumstances will take place at the next scheduled class meeting.

\*Homework: The "Homework" portion of your grade will be calculated as the average score of the homework assignments that you: (1) completed <u>and</u> (2) submitted by the due date. \*\*Engagement: The "Engagement" portion of your grade will be assigned by me as a numerical grade (i.e. 60, 85, 98, etc.) based on your **level of engagement** in this course. Examples of some factors that will be considered include: attendance, asking questions, answering questions, participating in group work, seeking help outside of class, etc. **I expect that you will attend all classes. While I understand that unexpected circumstances might sometimes arise, you can expect to see a significant reduction in your Engagement grade after two absences. I will provide you with a preliminary midterm assessment of your Engagement grade so that you will know where you stand and you will be able to make modifications going forward.**
