### **ACCOMPLISHMENTS**

*Teaching:* Taught numerous courses at the undergraduate and graduate levels in adult education, social and educational gerontology, action research, death and bereavement, spirituality, and baseball and American Culture. Teaching formats have included traditional classroom, compressed video, asynchronous online, and expeditionary. Frequent keynote speaker and facilitator at conferences, institutes, professional seminars, and pre-retirement education programs.

*Planning and Program Development:* Planned and developed over 100 courses, seminars, institutes and certificate programs for business, social service, health personnel and other professional audiences. Designed a statewide training plan in aging for the State of Connecticut and an education program for a community hospice. Co-founder of a statewide professional association and a university-based lifelong learning institute.

*Research and Publication:* Conducted numerous research projects, using both quantitative and qualitative methods. Special emphasis has been on applied research. Have published in professional journals and magazines in a wide variety of subject areas including adult education, continuing higher education, social work, gerontology, health, and baseball. Appointed as the first senior research fellow at the National Resource Center of the Osher Lifelong Learning Institute. In this capacity have conducted national research on older learners and founded a scholarly journal dedicated to explorations by and about older learners.
