

### Credential Review at USM

USM students may be able to earn credit for some licenses, certificates and credentials earned outside the traditional academic environment. Students wishing to earn credit through credential review should send proof of certifications to [priorlearningusm@maine.edu](mailto:priorlearningusm@maine.edu). **All certifications must be current (not expired) and non-provisional to be reviewed for credit.** Frequently reviewed credentials and trainings at USM are listed below. This is not a comprehensive list of all certifications that have been accepted for credit.
