**RELEASE AND ASSUMPTION OF RISK**

I acknowledge, declare and agree to the following:

That I have voluntarily agreed to participate in the use of the facilities and weight room of the Costello Sports Complex on the Gorham campus and/or Sullivan Complex on the Portland Campus of the University of Southern Maine, and in consideration of being permitted to the use of the fitness center and recreation complex for my active membership, do voluntarily execute this "Release and Assumption of Risk" on behalf of myself, my heirs and next-of-kin, my personal representatives and my estate.

That the University of Maine System and its University of Southern Maine (hereinafter referred to as the "University") has apprised me that there may be dangers and hazards inherent in the use of the fitness equipment and other recreation facilities and that I personally recognize and appreciate that such dangers and hazards exist. I accept and assume full responsibility for all harm and injury, of every nature, including death, which may occur to me or which I may suffer, and for all damages or loss to any personal property owned by me, while I am participating in the use of the complex and in furtherance therefore, I agree to indemnify and hold harmless the University, its trustee, faculty, employees and agents from and against any and all claims, demands, actions or causes of action, on account of damage or loss of my personal property, or my personal injury, or death, which may occur or result directly or indirectly from my participation in the use of the fitness center and not as a direct result of any negligent act of the University, its trustees, faculty, employees or agents.

I declare that I am able to physically withstand and cope with the indicated rigors of the use of the fitness center and recreation facilities, with or without an accommodation. If an accommodation is needed, I shall contact personal physician.

I request that this "Release and Assumption of Risk" be construed and interpreted pursuant to the laws of the State of Maine, and if any portion thereof is held invalid, I request the remainder continue in full force and effect.

I declare that I completely understand and have fully informed myself of the terms and conditions of the "Release and Assumption of Risk" by having read it all or having it read to me, before signing.

Minors under the age of 12 are not permitted in the facilities. No unaccompanied minors 12-17 are permitted in the facilities. Persons aged 12-17 years are permitted in the facilities only when accompanied and directly supervised within sight and vocal range, by a parent or guardian 18 years or older. Minors aged 12-17 must be supervised by parent or guardian of same gender in appropriate locker facilities (Unisex bathroom facilities are available, ask staff for locations). These policies apply to holders of day passes, as well as memberships.
