

Request for Dependent Tuition Waiver

The spouse, domestic partner* or dependent children of employees are eligible for a waiver based on the following: **Full-time Regular:** dependents enrolled within UMS system as a full-time student or as a part-time student who is matriculated are eligible for 50% tuition. **Part-time regular:** eligible

dependents (excluding PATFA) are eligible for a waiver of one-fourth tuition, provided that the spouse, domestic partner or child is attending a campus of the UMS system as a full-time student or as a part-time student who is matriculated. **PATFA:** dependents must be enrolled full-time and are eligible for 50% off tuition. (waiver does not apply to summer session) **Full time faculty:** dependents are eligible for a waiver of 55% tuition, provided that they are attending UMS system as a full-time student or part-time matriculated. Non matriculated dependents of full-time faculty may take summer/winter terms with 55% waiver of tuition.

<u>Graduate students</u>: Only the courses taken as part of an approved program of study for the degree qualify for the waiver. Please refer to your employee handbook or collective bargaining agreement at http://www.maine.edu/about-the-system/system-office/human-resources/, for more information on tuition waiver eligibility and availability of waiver for Summer Sessions.

The dependent child must be your or your domestic partner's natural, adoptive, or stepchild and must be economically dependent upon you for support, as is usually demonstrated by dependency status claimed on your federal tax return. This waiver does not apply to mini-courses or other non-semester course offerings or fees. This form must be completed prior to the beginning of each academic semester for which a waiver is requested and **after student is enrolled in course(s).**
